
Imagine Engineering with Local Second Grade Students

Legislative Update

As the 132nd Ohio General Assembly commenced, the OSPE Board of Directors took positions on seven new bills. One bill that doesn't at first appear to affect PEs is House Bill 29 (water reservoirs), which OSPE supports. This bill is to remove language from law that authorizes maintenance of buffers around municipal water reservoirs by contiguous property owners. The current law allows for vegetation maintenance by home and business owners, which may result in removal of biofilters utilized in design of the reservoirs. If made

law, responsibility of maintenance would be returned to the municipalities. Although the close of the 131st Ohio General Assembly brought the demise of House Bill 214 (piping materials selection), which OSPE opposed, similar legislation has recently been re-introduced in both chambers, and consequently OSPE is opposing both House Bill 121 and Senate Bill 95. Piping materials legislation has also been introduced in Michigan and South Carolina. As such, we must remain diligent in our lobbying of legislators to protect engineers' autonomy in specifying piping materials.
