
OCTOBER DSPE MEETING—11 OCTOBER 2018

SEPTEMBER'S ANNUAL LEGISLATIVE UPDATE MEETING

We want to express our sincere thanks to our participating State Legislators for their time and interest at our Annual Legislative Update. The Dayton Society of Professional Engineers hosted a Legislative Update as part of our Continuing Education outreach to Professional Engineers in the Dayton Region. From left to right in the photo, **Representative Niraj Antani (House District 42)**, **Representative Stephen Huffman (House District 80)**, **Senator Bob Hackett (Senate District 80)**, and **Representative Jim Butler (House District 41)** engaged in an open and very informative discussion with the luncheon participants.



An item of great interest to the engineering profession is **SB 255 (Occupational Licensing)**. SB 255 establishes a “sunset rule” revision for all licensing boards in the State. **OSPE opposes SB255** on the premise that it adds an additional administrative burden as the Board needs to move away resources from membership support to the sunset rule’s justification staffing. The Engineering profession upholds safety as one of its key reasons for its existence. Senator Hackett concurred that “common sense” must be an integral part of the execution of the occupational licensing reviews.

Rep. Huffman discussed **HB 211 (Home Inspectors)** that will require licensure for any entity involved in Home Inspections in the State. **HB 75 (Professional Licenses)** was addressed. The Legislators support Governor Kasich’s vision for the streamlining of the Professional Engineering licenses for the military spouses. The challenge for this legislation is the resulting “license by endorsement” which may open the door for individuals with different academic and experience levels than those required by the State of Ohio’s Engineering Board, impacting public safety.

Financing highways and bridges was another popular discussion area. The Legislators agreed that raising gas taxes was not an option to raise the required funding. The argument against a gas tax comes from the growing number of electric vehicles in the state and the growing out-of-state cargo vehicles that are part of the highway system but do not contribute to the resource base for the infrastructure’s maintenance and upgrade.

STEM education was discussed, in relationship to State’s investments in education. Terms like “a very under-educated” State was used to describe our educational demographics; 54% of Ohioans do not have a post high-school certification or degree. It is clear that K-12 education play a major role in our State’s ability to embrace new technologies. Another area of concern is the propensity of college graduates to leave the state after graduation, taking with them the needed intellectual capacity for the technological transformation of the State. One counter-example presented was the heavy investment of Amazon in the State and the opportunities for career growth Amazon will open to these graduates.

Additional discussion topics included the need for an aggressive protection of our water system against pollutants (Lake Erie’s algae was addressed) and the Opioid epidemic that impacts all economic sectors for the State.
