The FCC-OSPE Young Engineer of the Year award is presented in recognition of outstanding professional accomplishments of Ohio's Young Engineers and is based on the recipient's



scholastic achievement, accomplishments in Professional and Technical societies, civic and humanitarian activities, Engineering work, accomplishments and continuing competency, and technical papers and patents.

This year's recipient is Derek C. Kiss, P.E. Derek is a recent addition to NSPE/OSPE/FCC-OSPE having joined the society on December 1, 2022. However, his presence within our local Franklin County Chapter has been felt. About a year and a half ago, Derek started attending our monthly Chapter Luncheons as a Guest where he was welcomed by many of our Board members. Derek was approached about becoming a member of NSPE/OSPE/FCC-OSPE and he chose to join. Derek was invited to attend our FCC-OSPE Board meetings as a guest where his input and ideas were welcomed. As a Engineer/Young Young Professional, Derek has been

extremely successful in inviting other engineers to our monthly Chapter luncheons where they can receive 1 CPD hour toward their Continuing Education requirements for their PE license.

Derek C. Kiss, P.E. received a Bachelor of Science in Civil Engineering from The Ohio State University in May of 2014. He has approximately 9 years of Engineering experience and has his PE License in nine states: Florida, Kentucky, Louisianna, Massachusetts, Michigan, Ohio, Pennsylvania, South Carolina and Virgina. He is currently working in the Worthington, Ohio office of Civil and Environmental Consultants (CEC) as a Project Manager on small commercial and/or city utility projects. Derek is a skilled civil engineer designing site civil design projects, public and private utilities, roadway improvements, private commercial site institutional utility design, projects, infrastructure condition assessment/ rehabilitation, feasibility studies, floodplain management studies, large diameter sewer studies, construction administration, construction inspection, construction field testing, and City Engineer support Services.

Derek supports CEC's engineering efforts for capital improvement projects for various communities. He is an experienced engineer familiar with sound engineering practices related to a variety of public infrastructure projects. He has designed and developed construction plans and specifications for roadway improvements, sanitary and storm sewer improvements, pump station improvements, and water distribution system improvements, among others. He has also performed engineering design calculations, construction cost estimates, data collection, construction management, construction inspection, and field testing of equipment. He has a variety of different engineering experiences ranging

from preliminary investigations and studies through construction closeout, providing him a unique perspective of all the various aspects of a project. In Letters of

Recommendation received supporting Derek's nomination as the Franklin County Chapter of OSPE's 2024 Young Engineer of the Year, it was stated that Derek not only exhibits technical, engineering competence but he also displays commitment and support to colleagues and to customers.

The FCC-OSPE Citation award is presented to a Franklin County Chapter member with distinguished leadership in the Engineering Profession and in appreciation of selfless devotion to the highest ideals of service to Society and to Fellow Man; and for sustained contributions to the technical and professional aspects of the Engineering Profession. The recipient for this award shall be an Ohio Professional Engineer and shall not hold an elected office in the Chapter or be a Chapter Director of OSPE at the time the award is received. This PE shall not be a candidate for election to a public office nor shall hold an elected public office at the time the award is received.

This year's Citation Award recipient is Joe Bolzenius, P.E., P.S. Joe has been active in OSPE/FCC-OSPE since he joined on July 25, 2000. Joe received his Ohio Professional Engineer's license on July 8, 1991 and his Ohio Professional Surveyor's license on July 1, 1993. Joe also has PE licenses in five additional states including Indiana, Kentucky, Michigan, Pennsylvania, and West Virginia.

Joe served as President of FCC-OSPE for two consecutive terms from 2002 to 2004. Joe has also served as Chapter Vice-President for 5 years, Treasurer and MATHCOUNTS Chapter Coordinator from 2007 to 2017. Joe continues to be involved in the Chapter MATHCOUNTS program as Co-Coordinator and you will always see Joe in the Scoring Room at the Chapter and State competitions as well as he staffs the A/V equipment for the Countdown Round at both, the Chapter and State competitions. Joe has also been involved with the Future City Competition since 2008 and currently serves as the President of the Central Region Future City Competition. Joe continues to be active at the State and Chapter levels in other programs by

volunteering for the FCC-OSPE Engineer For A Day (EFAD) and as a Regional Science Day judge.

2024 FCC-OSPE Uncommon Engineer Award

The FCC-OSPE Uncommon Engineer award recognizes the long and distinguished service to the engineering profession; devotion and commitment to the state society and the local chapter; high standards of



professionalism; and guidance in the role of a team player. The candidate must be a registered PE and must be a member in good standing with OSPE. This is one of the highest awards that can be bestowed upon a Professional Engineer.

This year's award recipient is Joe Sullivan, P.E. Joe received his Ohio Professional Engineer's license on September 26, 1987 and has been active in NSPE/NSPE-OH/FCC-OSPE and the Engineer's Foundation of Ohio (EFO) since he joined the society on October 1, 1988. For NSPE-OH, Joe has served in the past as a Professional Engineers in Private Practice (PEPP) Trustee and as State Science Day Judge. For EFO, Joe has served for many years on Scholarship Committee and has been instrumental in completing Scholarship grading across the entire state of Ohio as many Chapters do not have Scholarship committees to complete the grading on the applications received. On the Chapter level, Joe has served as Vice-President for multiple years, Treasurer for 2 years, FCC Endowment Fund Committee member, Scholarship Committee Chair for many years, Regional Science Day Chair, and MATHCOUNTS proctor for many years.

For his contributions over the years, Joe has been awarded the following recognitions:

In addition to serving on these two boards, Joe is also serving on the Board of Directors for the ACE (Architecture, Construction and Engineering) Mentorship program of Central Ohio since 2015.

Joe is currently the Vice-President, Strategic Pursuits – Transportation Leader Regional Operations of Ohio for ms consultants, inc. In this position, he is responsible for overseeing the design and providing the technical review for a variety of transportation projects. His Engineering expertise encompasses most aspects of Transportation related Infrastructure projects. Joe is currently the Project Principal for the Ohio Department of Transportation (ODOT) \$300 million, "Big Build" project and he has been instrumental in this Project's success which is showcasing his Strategic Vision and meticulous attention to detail.

The project must have been completed during the calendar year preceding the award, i.e. for this 2024 Award, the project must have been completed in 2023. The project location may be outside of the Chapter area however, the majority of the project work (i.e. Project Management, Design, Engineering, etc.) must be completed by a company(ies) located within the Chapter area.

The 2024 FCC-OSPE Outstanding Engineering Achievement award is being presented to Civil & Environmental Consultants, Inc. (CEC), Worthington office for the Ross County Correctional Institution Improvements project. The project's multifaceted nature, addressing structural, mechanical, electrical, and plumbing issues, showcases a comprehensive and integrated engineering approach.

CEC played a pivotal role in providing professional services to assist the Ohio Facilities Construction Commission (OFCC) and the Ohio Department of Rehabilitation and Correction (DRC) in addressing several critical challenges within the Ross County Correctional Facility.

Ross Correctional Institution sought assistance to address the structural, mechanical, electrical and plumbing issues that this facility is experiencing. CEC was chosen to provide professional services to assist the Ohio Facilities Construction Commission and the Ohio Department of Rehabilitation and Correction to address these issues, and others as they may arise during the course of the work, which was in excess of \$5M total project cost. Deteriorating concrete beams are being patched, leaking plumbing is being replaced, sprinkler systems, lighting and audio systems are being replaced, electrical wiring and conduits inspected and replaced as necessary, floor drains inspected and replaced, and acoustical ceilings replaced.

By integrating various engineering disciplines, this Project serves as a model for addressing complex challenges within critical infrastructure, setting a high standard for excellence that aligns with the goals of the Ohio Outstanding Engineering Achievement Award.


