He has an overall grade point average of 3.68, and maintains an impressive list of professional, non-professional and social organization memberships. His selection is based on the recommendation of the chair of the Department of Mechanical Engineering of OSU.

Outstanding Engineering Educator: David J Bayless PhD PE. Present Position: Gerald Loehr, Ohio University Professor of Mechanical Engineering. Education: BS Mechanical Engineering University of Missouri; MS Engineering Management- University of Central Florida; PhD Mechanical Engineering, University of Illinois; Executive Leadership Institute, Ohio University. Extensive scholastic honors in national defense, environmental restoration, energy fields. Memberships: Mechanical Engineering and Engineering Honor Societies, Coal utilization Research Council; Active Professional Education: Eight years Nuclear Propulsion officer/instructor, United States Navy and National Science Foundation Graduate Fellow- University of Illinois; Twenty Five years- Assistant, Associate and Full Professor of Mechanical Engineering, Ohio University.

Outstanding Engineering Achievement: I-70/I-270 Bridge Fire Response and Reconstruction. On July 1, 2015 a tanker truck carrying 8000 gallons of denatured alcohol overturned on the ramp carrying I-270 SB to I-70 EB in west Columbus, resulting in a fire causing extensive damage to the eastbound mainline I-70 bridge over the ramp. The necessary bridge structure and reconstruction posed a major

traffic disruption and required a bridge structure reconstruction of a demanding and unique nature. The effective and timely traffic modifications and structure reconstruction displayed the efforts of the Ohio Department of Transportation District Six at its operational best.

Legislator of the Year- Cheryl L Grossman – House District 23: State Representative Cheryl Grossman is presently serving her fourth term in the Ohio House of Representatives. She represents the 23rd House District, which includes Grove City, Jackson Township, portions of Hilliard, and the City of Columbus and five adjacent townships. She served as assistant majority whip during the 129th general assembly and majority whip during the 130th. Representative Grossman served as mayor of Grove City from 1996 to 2008 after serving as Council member and Council President. Representative Grossman and her family are lifelong residents of Grove City. She has been Representative of the Year for a number of Years.

STAR CHAPTER Award: A STAR Chapter award submission has been made by the Franklin County Chapter. The submission involves a summary of the efforts and effectiveness of the Chapter in seventeen specific areas in the past year. The chapter has been consistently successful in the efforts to be designated as a “STAR” Chapter by the OSPE evaluation committee.

## Technology Progress

Technology has progressed since I first started my career in the Fayette County Engineer’s Office. We reviewed new surveys by doing long hand closures of the written deeds. The closures were to check that the property description was correctly copied and was accurate. Closure consisted of traversing the tract using bearings and distances on a hand written form. Using a five-place logarithms and a hand crank adding machine the size of a typewriter, the error of closure was calculated. One time I could not close a deed, but the surveyor insisted I was wrong. He came to the office and showed me on his new HP-35 where I was wrong. I had copied a logarithm wrong for one course. Needless to say, I was very embarrassed.

Now with computers the results are easier done and printed list of numbers for a quick check and you don’t have to prorate the fractional parts of the bearings from the logarithm table. I remember inking on linen tax maps with holes from the many erasures, to now the maps can be stored on line. Times are changing; I hope I didn’t bore you with stories from the past.

## Summary, January Luncheon Presentation Ethics - Ohio Engineering Law and Rules

Our luncheon presenters have been outstanding. We have been very fortunate; the presentations have been extremely informative. In addition, they kept us sitting up in our seats with appropriate quips. Bill Lhota's presentation "Ethics Law and Rules" was no exception. If you were not here you missed a great one. With the passage of House Bill 17, Professional Engineers need to know the law; you still need to know your limits of expertise.

The legislative power of the state of Ohio is vested in the General Assembly consisting of a Senate and House of Representative by Ohio's Constitution. The Ohio Revised Code (ORC) contains the laws enacted by the General Assembly. The Ohio Administrative Code (OAC) contains the rules developed by state agencies as provided for in the ORC.

The State Board of Registration for Professional Engineers and Surveyors in a state agency that is created by the ORC and has developed rules contained in the OAC. It is the responsibility of all Professional Engineers to know and follow the laws and rules of the Board.

The ORC provides that the Board may discipline PE's for violating the laws and rules pertaining to PE's. Specifically, the Board may fine, revoke, suspend, refuse to renew, or limit the registration, or reprimand, place on probation, deny an applicant the opportunity to sit for an examination or to have an examination scored, or impose any combination of these disciplinary measures on any applicant or registrant, or revoke the

certificate of authorization of any holder found to be in violation of laws and rules contained in the ORC and OAC.

The Board, as directed by the ORC, has a Code of Ethics in the OAC that shall be binding upon every person holding a certificate of registration as a professional engineer. Additionally, every person holding a certificate of registration as a professional engineer is charged with having knowledge of the existence of the reasonable rules and regulation provided in the OAC for his or her professional conduct as an engineer, and also shall be deemed to be familiar with their several provisions and to understand them.

If you are not familiar with the Code of Ethics for Engineers and Surveyor go to Ohio Administrative Code section 4733-35 and become familiar as you are to be guided by the Code in all your actions as a Professional Engineer.

## Regional MATHCOUNTS Summary

## Why I belong to the Ohio Society of Professional Engineers

Many professional engineers ask why they should join Ohio Society of Professional Engineers (OSPE). The following is a very good example what our very prestigious organization contributes to our profession. Our last luncheon program on Ethics Law was indeed timely, in the passage of House Bill 17. In addition, OSPE gave strong support for the passage of the House Bill, including crucial testimony.

Governor Kasich signed Ohio House Bill 17, which will become law in 90 days from February 14. The bill provides civil immunity for engineers, surveyors, architects, contractors' et al, who provide necessary services during declared emergencies. This legislation was cosponsored by one of our members, State Representative Louis W. Blessing, III, PE.

In testimony to the committees of the Ohio House of Representatives and the Ohio Senate, OSPE explained that "House Bill 17 would place in Ohio law a 'Good Samaritan' provision to protect professional

engineers, surveyors and architects, from being held liable in damages in a civil action in relation to volunteering their professional services during or immediately following a declared emergency. The professionals will volunteer their expertise and professional services under the direction of a public official."

OSPE further stated that "House Bill 17 would provide protection for our professional engineers who wish to contribute their time and expertise, without compensation, for the health and safety of the public in the event of a declared emergency. The sole intent is for experienced design professionals to provide their best practice and judgment in determining the safety of situations and structures prior to the release of safety services, and search and rescue teams."

It is highly recommended that all professionals review House Bill 17, and contact their lawyers for proper interpretation of the bill, before acting in a "Declared Emergency".

## NSPE Interview Dennis Irwin, PhD, PE, President, Ohio Society of Professional Engineers

The 2016 March/April of NSPE's PE magazine published an interview with Dennis Irwin, Dean of the Russ College of Engineering and Technology at Ohio University, and current President, Ohio Society of Professional Engineers.

Below is an excerpt from that article where PE asked "What is your stance on licensure in academia"?

Irwin's response: It's changed a little bit. I was probably luke warm when I first got active in OSPE. Now I'm a pretty strong advocate for it. But not for [the traditional reason of competence]. I've been around faculty members most of my life. They're competent people.

The important part is the shared Code of Ethics. Because nobody is competent enough to do everything. You have to apply the Code of Ethics and what it tells you to do. As far as I know, every state says that if you're not qualified, you must not do the work. It's left up to us to make that decision.

That applies to teaching as well. If I ask someone to teach a course way out of [his or her] area of expertise, it would bother me if [that person] didn't hesitate.


